INSTRUCTIONS TO TENDERERS

GENERAL

1. Army Public School, Dhaula Kuan invites Tender through 2 bids system (i.e., Technical and Financial bid) from eligible applicants who fulfill qualification criteria as stipulated in **Annexure VI**. Cost of this Tender form Rs 500/- (Rupees five hundred only).

SUBMISSION OF TENDER

- 2. The tender complete in all respects shall be submitted along with Earnest Money Deposit (EMD) of **Rs 50,000/-** (Rupees fifty thousand only) drawn in the form of a demand draft in favour of "Army Public School, Dhaula Kuan", payable at New Delhi. Tender without Earnest money Deposit are liable to be rejected. In case the tender is not accepted, this money will be refunded to you (without interest) at the time of opening of tenders. You will be required to write an application to us asking for the same.
- 3. Tender form will be submitted in a sealed cover only. Address and Telephone number of the contractor must be mentioned on the opposite side of the envelope. Technical Bid and Commercial Bid will be enclosed in two different envelopes clearly mentioning Technical Bids / Commercial Bids. Both envelopes will subsequently be placed together in a third outer envelope.

- (ii) <u>Commercial Bid</u> Price bid duly filled with individual item rates, corresponding amount and total price as per the BOQ (Annexure –VIII).
- (c) All the documents submitted with the tender form should be arranged in serial wise manner and marked with flags.
- 7. <u>DEVIATIONS TO TENDER CLAUSES</u>. Tenderers are advised not to stipulate any deviation. Conditional tenders are liable to be rejected. Tenderer should have valid PAN, Registration and GST numbers.

8. AWARD OF WORK

- (a) Work will be awarded to the lowest tenderer for the entire scope of work including taxes, subject to the work experience and fulfillment of other terms and conditions and specifications.
- (b) School also reserves the right to accept or reject any tender in part or full without assigning any reason whatsoever. The school will also reserve complete rights to award only a part of the entire scope of work at the time of placing work order in case the requirement of a particular job / work is not found required/justified.
- (c) School also reserves the absolute right to reject any or all the tenders at any time solely based on the past unsatisfactory performance by the tenderer(s).
- (d) The contract will be awarded on turnkey basis which will include complete jobs specified in the tender. L-1 vendor for the contract will be calculated based on the lowest consolidated bid offered for the complete job (including GST). Separate job wise contracts will not be considered.

9. **CORRECTIONS / AMBIGUITIES**

- (a) All corrections in the schedule of rate should be initialed.
- (b) Inconsistencies / ambiguities in the price bid (schedule of quantities) shall be dealt with in accordance with the following rules: -
 - (i) This is an item rate tender, only rates quoted shall be considered. Any tender containing percentage below / above the rates is liable to be rejected.
 - (ii) Rates quoted by the tenderer in figures and words shall be accurately filled. If a discrepancy is found, the rates, which are in words, shall be taken as correct.
 - (iii) In the event no rate has been quoted for any item(s), leaving space blank, it will be presumed that the contractor has included the cost of this / these item(s) in other items and rate for such item(s) shall be considered as zero and work will be required to be executed accordingly.
- 10. **FIRM RATES**. The rates quoted by tenderer shall remain firm till completion of all works even during the extended period.

- 11. <u>EMD</u> of the unsuccessful tenderer shall be refunded without any interest after completion of the tendering process by submitting an application for refund of EMD. The EMD of successful tenderer will be refunded after submission of PSD.
- 12. PERFORMANCE SECURITY DEPOSIT (PSD). A Performance Security Deposit (PSD) of 3% of the total contract value (incl GST) from a nationalized or private sector bank will be payable by the vendor to the school. The validity of the PSD must be of two years from the successful completion of all the contractual obligations. A period of one year will be observed as the defect liability period during which the vendor will be responsible for all faults/repairs arising from the executed work. The PSD will be returned on successful completion of the defect liability period. In case the execution of the contract is delayed beyond the contracted period and the purchaser grants extension of delivery period, with or without LD (Liquidated Damages), the supplier must get the PSD revalidated, if not already valid.
- 13. PAYMENT TERMS. 100% of the payment will be made after completion of the specific Job and satisfactory assessment by the school authority and the BOO. It will be ensured by the selected bidder that all works are executed in a logical sequence so that a subsequent Job does not cause damage or alters a completed Job. The selected bidder will necessarily be required to get the plan of project execution approved from the school authorities before commencement of the project.
- 14. <u>SCHEDULE OF WORK</u>. The entire work under the contract must be completed in all respects by the vendor within a period of 60 days from the date of the work order. Extension can only be granted at the sole discretion of the school management under unmanageable conditions on receipt of application from the vendor stating specific reasons for extension. The structural Repair work included in the scope of work is required to be carried out only by an approved agency and will accordingly be certified on completion.
- 15. <u>DISPOSAL OF OLD ITEMS</u>. Bidder will account for and stack all saleable and non-saleable items which come out during work of dismantling and Repair and resurfacing of internal road and parking area work.
- 16. CLEARANCE OF DEBRIS. The contractor will be responsible for lifting of all debris from the site and its disposal as per Govt. regulations.
- 17. PENALTY FOR UNSATISFACTORY/ NON-COMPLETION OF WORK. In case of unsatisfactory work or non-completion of work by the contractor within the stipulated time i.e., 60 days from the date of issuing work order by the school, a penalty of 0.5% per week of the total job cost at a max of 10%, as applicable will be levied to the contractor and the penalty amount will be deducted from the final payment to the contractor. The defect liability period will automatically shift to one year from the new date of satisfactory completion of all the contractual obligations.

ANNEXURE - II - TENDER CONDITIONS (CONTD...)

- 1. In any case, if tenders are not opened due to any reason, the tender documents, and EMD shall be returned to all bidders.
- 2. Conditional tenders will not be accepted.
- 3. A tenderer shall submit only one bid in the particular tendering process. A tenderer who submits or participates in more than one bid, will cause all of the proposals in which the tenderer has participated, to be disqualified. No tenderer can be a sub-contractor while submitting a bid individually in the same bidding process. If the tenderer does not meet the criteria stated above, the tender shall be considered ineligible for participation in tender process and they shall be considered ineligible applicants.
- 4. If there is any misrepresentation of facts with regards to undertaking submitted, the same will be considered "fraudulent practice" and the tender submission of such tenderer will be rejected.
- 5. EMD/Performance Security of successful bidder may be forfeited, if the bidder withdraws or amends or deviates from the tender in any respect.
- 6. The EMD/performance security shall be forfeited in case: -
 - (a) If the bidder withdraws or amends, impairs or derogates from the tender in any respect within the period of validity of this tender.
 - (b) If the bidder having been notified of the acceptance of his tender by the APS, fails to undertake the work during the period of its validity,
 - (c) If the bidder fails to furnish the Performance Security for the due performance of the contract.
 - (d) If the bidder fails to sign the agreement.
 - (e) Fails or refuses to execute the contract.
 - (f) Fails to respond to queries by the APS.
- 7. APS Dhaula Kuan will not compromise with the quality/sub-standard material. At any stage, if it is found that supplier has supplied inferior quality or different specifications, the payment shall be made for such items after reasonable deduction(s)/ rejection of the lot and forfeiting of Performance Security/ EMD, as deemed fit, in the circumstances & as decided by the school.
- 8. The rates quoted by the bidder shall be complete for installation of one large porta cabin as per the specification(s) and shall be inclusive of all applicable tax, duty (ies) loading, unloading, packing, transportation from works to APS, installation etc. and nothing extra/additional shall be payable on these rates.
- 9. The school can ask for any clarifications & documents at any stage of the procurement depending upon the circumstances to ascertain quality of material used.

- 16. The bidder will be required to arrange for police verification of all his staff & labour and be responsible for their security and administration.
- 17. APS reserves the right to accept or reject any/all tenders without assigning any reason.
- 18. **QUALIFICATION CRITERIA**. The tenders for this contract will be considered only from those tenderers who meet requisite eligibility criteria as mentioned below: -
 - (a) Firm should be registered. Certificate of Registration will be submitted.
 - (b) EMD of Rs 50,000/- (Rupees fifty thousand only) is submitted by the bidder meeting validity conditions.
 - (c) The firm must have experience of minimum 5 years or more in the same field. Supporting documents (work order/sanction order) to be attached.
 - (d) Tenderer should have undertaken at least two single works of similar nature each of minimum value of at least 10 lacs (including tax).
 - (e) The annual turnover of the tenderer should not be less than Rs. 50 Lakhs in the field of construction/repairs in at least two of the last five financial years.
 - (f) Following documents to be submitted by the bidder: -
 - (i) Proof of service Tax Number, Sales Tax Number, GST Number, PAN Number.
 - (ii) Income Tax return of last two years.

- (i) The firm should not have been black listed from any Gov./Ministry/PSU Organization.
- (ii) The firm should not have been penalised for non-performance / execution or completion of task of more than 10% of contract value in any contract.
- (iii) Tenderer must not have been suffered bankruptcy / insolvency during the last 5 years.
- (h) The tender submission by tenderers, who do not qualify the minimum qualifying eligibility criteria, shall not be considered for further evaluation and therefore rejected.
- 19. **ARBITRATION CLAUSE**. That in case of any dispute between first party (APS) and the other party (Bidder) arising out of or in relation to the agreement, the dispute shall be referred to Hon'ble Chairman for arbitration. The award of the said Arbitrator shall be binding upon both parties. The seat of the arbitration shall be at APS Dhaula Kuan, New Delhi.

20. RIGHT OF ACCEPTANCE OF OFFER

- (a) The APS reserves the right to accept partly or reject any offer without assigning any reason thereof. The APS does not pledge itself to accept the lowest or any other tender and reserves to itself the right of acceptance of the whole or any part of the tender or portion of the qty. Bidder shall supply the same at the rate quantity offered.
- (b) In respect of enquiries, which call for procurement of more than one item, the APS reserves the right to consider and accept the offer for any of the items in the enquiry reserving the right to utilize the offer for balance items at a later stage within the validity of offer.

21. FORCE MAJEURE

- (a) Should any force majeure circumstances arise, each of the contracting party shall be excused for the non-fulfilment or for the delayed fulfilment of any of its contractual obligations, if the affected party within 14 days of its occurrence informs in a written form the other party.
- (b) Force majeure shall mean fires, floods, natural disasters or other acts such as war, turmoil, strikes, sabotage, explosions and quarantine restriction beyond the control of either party.
- 22. RIGHT TO VARIATION CLAUSE. To take care of any change in the requirement during the period between issue of RFP and conclusion of contract, APS reserves the right to increase or decrease the quantity of the required deliverables by 50% without any change in the terms & conditions and prices quoted by the bidder. While concluding the contract, the quantity can be accordingly increased or decreased at the same terms of conditions.
- 23. <u>LIQUIDATED DAMAGES (LD)</u>. In the event of the BIDDER's failure to submit the Bonds/Guarantees/ Documents or/and supply/perform the items/services as per Delivery schedule specified in the contract, the APS may, at his discretion, withhold any payment until the completion of the contract. The APS may also deduct LD to the sum of 0.5% of the contract

price of the delayed/undelivered stores/ services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores/services.

- Bidder can modify his bid any number of times before bid submission closing date and time. Bidder can also withdraw his bid before bid submission closing date and time. Withdrawn is allowed only once in a tender. If a bidder withdraws his bid, he cannot participate in the particular tender again.
- The Bidder shall abide by all the rules and regulations related to labour laws, accident, workmen compensation act, workmen insurance, ESI, PF, etc. This will be the sole responsibility of the bidder. APS will not be a party at any stage in any of the disputes relating to the above. In case, any liability arises due to non-conformance by the bidder, under no circumstances APS will be liable for the same.
- TERMINATION FOR DEFAULT. The APS may, without prejudice to any other remedy for breach of contract, by written notice of default, sent to the bidder, terminate this contract in whole or in part in case of the under mentioned reasons: -
 - If the bidder fails to deliver any or all the services within the time period(s) specified it the contract, or any extension thereof granted by the APS.
 - If the bidder fails to perform any other obligations under the contract.
 - If the bidder, in either of the above circumstances, does not remedy his failure (b) within a period of 15 days (or such longer period as the APS may authorize in writing) after receipt of the default notice from the APS.
 - On a notice period of 30 days. (d)
 - In the event the APS terminates the contract in whole or in part pursuant to above para, the APS may hire the bidder at the risk and cost of working bidder under contract as APS deems appropriate. However, the bidder shall continue the performance of the contract to the extent not terminated.

SCOPE OF WORK: INSTALLATION OF 2 x PORTA CABINS (PRE-FEBRICATED SHELTER) AT ARMY PUBLIC SCHOOL, DHAULA

	Description
<u>S.No</u>	Foundation and Wall. Foundation shall be provided with brick masonry in CM (1:4) with PCC (1:4:8). Depth of foundation will be 2 ft below GL. Above GL up to PL (height - 450mm) over a brick masonry step foundation in cement mortar 1:4,15 mm thick cement plaster in cement mortar 1:6 will be done on brick masonry above ground level. To be matched to existing nearest building.
$\frac{1}{2}$	Flooring.
	(i) For Verandah - Kota stone flooring with Jaisalmer stone border (6") jointed with grey cement slurry mixed with pigment to match the shade of the stone including rubbing and polishing complete over Cement mortar screed bed 25 mm thick in CM (1:4) laid over 100mm thick PCC sub base 1:4:8, using 40 mm graded stone aggregate. For Rooms, branded vitrified tiles of approved design.
	(ii) MS Hand railing with approved design around the verandah. It should connect to the existing verandah of the old construction which is at a gap of 20ft covered with PPGI sheets.
3	Wall: The walls shall be of composite panels made out of two plain Gl. Sheet of 18 Guage thick of the outer, resin bonded with PUF 80mm thick (sandwiched between the Gl Sheets). Density shall not be less than 40 kgs/m3. The panels to be colour coated white in desired colour. Series of these panels shall be joined together with Gl 'H', 'C', 'L', 'Z' and other sections to form the complete wall.
4	Roof . Roof slope shall be 1:4 approx with .50mm PPGL sheets. Span of the structure is 20 ft plus the verandah of 10 feet, which is also to be roofed: the height at eaves shall be 11 feet and 14 feet at centre gable . The roof shall be done with insulated tensile alvalume sheet. The inner and outer surface of each panel shall consist of a 0.5- 0.6mm thick hot dipped high tensile galvalume sheets. PUF density must conform to 40+2 kg/m3. The roofing would be laid over a frame works of trusses and purlins pressed using suitable fasteners like screw with works screw with washers and bitumen washers etc. Trusses shall be fabricated with 80mm x 40mm x 4.80mm thick MS hollow rectangular section and purlins should be provided with 50mm x 25mmx4mm thick MS hallow rectangular section. All fitments and materials must confirm to BIS standards.
5	Roof Projection. The roof shall have min projection of 1.5' and 1'from the gable walls. Purlins will also be provided on the roof at the eaves and at the gable roof extension (outside the structure)
6	Roof Structure Frame Work. The roof shall be laid over a frame work of trusses purlins and columns fixed using suitable fasteners, nuts & bolts, Steel & bitumer washers etc. The trusses shall be made using MS hollow rectangular sections of size 80x40x3 mm conforming to IS 4923:1997). The trusses are provided at equal distance


